Privacy Notice Regarding Personal Data Processed Through Cookies

Dear Website Visitor,

This privacy notice is prepared in accordance with Law No. 6698 on the Protection of Personal Data ("Law") and Communique on Principles and Procedures to Be Followed in Fullfillment of The Obligation to Inform. It aims to provide you with details regarding the collection and processing of your personal data through automated means via the use of a cookie placed on your device by our website with the domain name www.yazicioglulegal.com ("Website") and information on the type of cookies we employ, their purposes, and how you can manage these cookies.

The "Data Controller" regarding the processing of your personal data is Att. Bora Yazıcıoğlu in case you access our Website and utilize the services available on it.

You can see the types of cookies used on our website via the settings tab of your browser.

1. Types of Cookies Used in our Website

1.1. Types of Cookies According to Duration of Use

Session cookies are used to ensure the continuity of the session and are automatically deleted when you close your browser. Persistent cookies, on the other hand, are not deleted when you close your browser and are automatically deleted after the expiration of the time period for their storage.

The cookie used on our website is a session cookie.

1.2. Types of Cookies According to Parties

Whether a cookie is a first-party cookie or a third-party cookie depends on the entity placing the cookie. First-party cookies are those placed directly by our Website, which is the URL www.yazicioglulegal.com visible in your browser's address bar. Third-party cookies, on the other hand, are placed by a URL address other than www.yazicioglulegal.com visible in your address bar

The cookie used on our website is a first-party cookie.

1.3. Types of Cookies According to Purpose of Use

Regarding their purpose, cookie types can be divided into strictly necessary cookies, functional cookies, performance-analytics cookies, and advertising/marketing cookies. The cookie used on our website is a strictly necessary cookie.

Strictly Necessary Cookie

These cookies are strictly necessary for the operation of our Website and your personal data are used for the accurate functioning of our Website. These cookies are used mandatorily in order to fulfill the service you have requested (ensuring the continuity of the session).

2. Information on the Purposes and Legal Bases of Processing Your Personal Data and the Cookies Used

Your personal data collected through the cookie on our Website are processed within the scope of Article 5(2)(f) of the Law which states "Data processing is mandatory for the legitimate interests pursued by the data controller, provided that this processing shall not violate the fundamental rights and freedoms of the data subject". Information about the strictly necessary cookie used on our Website is given in the table below:

5. What are Your Rights?

You may submit an application at any time for exercising the rights specified in Article 11 of the Law regarding your personal data. You may submit your applications to the following address of Att.
